SUBMITTAL REQUIREMENTS

Grading plans and activities must be in accordance with Appendix J, Grading, of the currently adopted edition of the International Building Code.

Please check each item being submitted and include with the completed application.

Site Plan showing:

- Property boundaries and area(s) to be disturbed
- Building and parking locations
- Identify the use and occupancy for which the proposed work is intended

Grading Plan:

- Estimated quantities of excavation and fill
- Material storage sites and disposal areas
- Soils report for residential subdivisions and commercial and institutional uses. *A soils report is not required where the building official determines that the nature of the work applied for is such that a report is not necessary.*

Copy of Utah Pollution Discharge Elimination System (UPDES) Permit (includes Erosion Control Management Plan) *UPDES permit required if disturbed area is greater than one acre.

For fills greater than 6", soils reports for fill material must be submitted that include, at a minimum:

- Borrow site
- Soil classification
- Compaction information, and other characteristics



THE CONTRACTOR SHALL PROVIDE A MINIMUM OF 24 HOURS' NOTICE PRIOR TO BEGINNING ANY WORK BY CALLING THE CONSTRUCTION INSPECTOR AT (435) 259-4941.
